PUBLIC HEARING

3. Project No: GP25-0001, R25-0001, MFSDP25-0001, & TSM25-0001

Applicant: Santa Fe Flores LP

Request: A request for entitlements to construct a multi-family residential development consisting of 46 condominium units on a 2.6-acre vacant site, at 17.69 du/ac density, located on the northwest corner of South Santa Fe Avenue and North Las Flores Drive. The project proposal includes seven three-story buildings, consisting of 46 three-bedroom units, each with an attached two-car garage and private open space, with common open space and recreational amenities.

Recommendation: Staff recommends approval to City Council

Senior Planner Sarah Cluff and Senior Civil Engineer Bradley Holder: gave the staff presentation.
Rick Gittings, applicant representative: gave the applicant presentation.

OPEN PUBLIC COMMENTS

Ann Sullivan, a resident expressed concerns regarding the proposed project, including the placement of high-density housing adjacent to the liquor store, limited green space due to steep site topography, potential traffic impacts and overall citywide cumulative effects, and the need for more diverse or accessible housing types. She also suggested that the City pause additional development until existing new housing reaches higher occupancy levels.

Planning Commissioner discussions: The Commissioners discussed the project's overall suitability for the site, noting its thoughtful design, appropriate amenities, and consistency with City planning and zoning requirements. They highlighted the project's strengths as a well-designed urban infill development with proximity to transit, adequate parking, and no requests for development waivers. Commissioners acknowledged the concerns raised by the public regarding growth, infrastructure, and cumulative development impacts, clarifying that the property already had existing entitlements and that the decision before them involved a transition from previously approved apartments to for-sale condominiums. Commissioners also encouraged residents to remain informed and continue engaging in the planning process by attending Planning Commission meetings, City Council hearings, and upcoming community workshops related to the General Plan and housing initiatives.

Applicant response: The applicant representative clarified that the new fire station will be constructed before project completion, that the traffic study evaluated a broader network beyond the immediate project area, and that the project addresses ongoing regional housing demand while improving a long-vacant site.

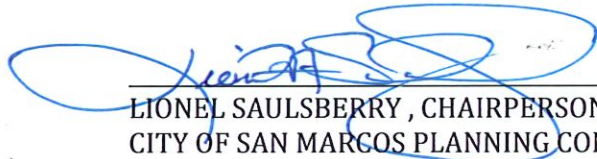
DISCUSSION ITEM: None
