A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2025-26 OPERATIONS BUDGET TO APPROPRIATE FUNDING FOR ENHANCED E-BIKE EDUCATION AND ENFORCEMENT ACTIVITIES

WHEREAS, in recent years, e-bike safety has become a growing community concern in San Marcos, especially the safety of young riders; and

WHEREAS, given that San Marcos is a community with many young families, the City Council has taken a leadership role to increase safety, raise awareness of the rules of the road and step up enforcement; and

WHEREAS, on July 9, 2024, the San Marcos City Council adopted an ordinance codified as San Marcos Municipal Code Chapter 12.25 regulating the use of e-bikes and partnered with the San Marcos Unified School District to create an e-bike permit and safety training program at local middle and high schools; and

WHEREAS, on Jan. 1, 2025, a new California law, AB 2234 (Boerner, 2024), went into effect that allows cities in San Diego County to prohibit the use of Class 1 and Class 2 e-bikes by those under 12 years of age; and

WHEREAS, the City Council is adopting an resolution prohibiting persons under 12 from operating class 1 and 2 electric bicycles; and

WHEREAS, the City Council would like to further enhance e-bike safety education and enforcement; and

WHEREAS, city staff has identified programs and activities to accomplish this goal;

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of San Marcos does hereby amend the Fiscal Year 2025-26 Operations Budget and appropriate Measure Q funding for the following:

- \$25,000 for Sheriff's deputy overtime dedicated to e-bike education and enforcement.
- \$16,500 for enhanced e-bike safety education and training in San Marcos, partnering with a local mobility organization and the San Marcos Unified School District.
- \$20,500 for the production and installation of signs prohibiting e-bikes on sidewalks in business districts.
- \$15,000 for the production and distribution of outreach and education materials, including safety cards, and signage with QR codes.
