

RESOLUTION NO. 2016-XXXX

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS ADOPTING THE BUDGET OF THE CITY OF SAN MARCOS FOR THE FISCAL YEAR BEGINNING JULY 1, 2016 AND THE CAPITAL IMPROVEMENT PROJECTS BUDGET FOR THE FIVE YEARS ENDING 2020-21, AND APPROPRIATING MONEY OUT OF THE TREASURY FOR SUCH PURPOSES

WHEREAS, the City Manager has presented to the City Council, Fiscal Year 2016-17 Operations and Maintenance Budgets for the City of San Marcos and a Capital Improvement Projects Budget for Fiscal Years 2016-17 through 2020-21 (collectively "Budgets"); and

WHEREAS, the salary projections contained in the Budgets are based upon the Fiscal Year 2016-2017 Classification and Compensation schedule, and

WHEREAS, the City Council has reviewed and studied said proposed Budgets, making modifications as deemed desirable; and

WHEREAS, the appropriations as listed within the respective Budgets will provide the level of services deemed appropriate by the City Council.

NOW, THEREFORE, BE IT RESOLVED that there is hereby appropriated out of the Treasury of the City of San Marcos for municipal purposes and use by the various departments, the amounts shown in the Budgets.

BE IT FURTHER RESOLVED that the Fiscal Year 2016-2017 Classification and Compensation is approved as presented in Exhibit A.

BE IT FURTHER RESOLVED that the aforementioned Budgets are approved and that the City Manager is authorized to transfer funds within the control accounts and the various departments and funds (including transfers from department to department and fund to fund) and to make expenditures necessary to accomplish the purposes set forth in the Budgets, including, but not limited to, the acquisition of necessary rights of way and executing the agreements associated therewith, provided no change is made in the total

budgeted appropriations unless approved by the City Council. The City Manager is hereby authorized and directed to make the appropriate adjustment to each departmental budget as outlined herein and to cite this Resolution as authorization therefor.

BE IT FURTHER RESOLVED that all demands against the City arising out of or in connection with the above described Budgets shall be prepared, presented to, filed and paid as authorized by the provisions of the City procedures, as may be in force, prescribing the means and method of presenting the payment of demands by the City of San Marcos.
