A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS, CALIFORNIA, REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN DIEGO TO CONSOLIDATE A GENERAL MUNICIPAL ELECTION OF SAID CITY TO BE HELD ON TUESDAY, NOVEMBER 8, 2016 WITH THE STATEWIDE GENERAL ELECTION TO BE HELD ON SAID DATE PURSUANT TO SECTION 10403 OF THE ELECTIONS CODE

WHEREAS, the City Council of the City of San Marcos has called a General Municipal Election to be held on Tuesday, November 8, 2016 for the purpose of the election of two (2) Members of the City Council; and

WHEREAS, it is desired that the General Municipal Election be consolidated with the Statewide General Election to be held on the same date, and that within the City the precincts, polling places and election officers of the two elections be the same, and that the Registrar of Voters of the County of San Diego canvass the returns of the General Municipal Election, and that the election be held in all respects as if there were only one election.

NOW, THEREFORE, the City Council of the City of San Marcos, California, DOES HEREBY RESOLVE, DETERMINE, AND ORDER as follows:

- <u>SECTION 1</u>. That pursuant to the requirements of Section 10403 of the Elections Code, the Board of Supervisors of the County of San Diego is hereby requested to consent and agree to the consolidation of a General Municipal Election with the Statewide General Election on Tuesday, November 8, 2016 for the purpose of the election of two Members of the City Council.
- <u>SECTION 2</u>. That the Registrar of Voters is hereby authorized to canvass the returns of the General Municipal Election. The election shall be held in all respects as if there were only one election, and only one form of ballot shall be used.
- <u>SECTION 3</u>. That the Board of Supervisors is requested to issue instructions to the Registrar of Voters to take any and all steps necessary for the holding of said consolidated election.
- <u>SECTION 4</u>. That the City of San Marcos recognizes that additional costs will be incurred by the County by reason of this consolidation and agrees to reimburse the County for costs for services upon the presentation of a properly submitted invoice.
