## I. REPORT OF COMPLETION

## A. Location and Description of Project

1. Location of Project: Civic Center, Public Works Administration, Woodland Park Community Pool.

Description of Project: The work consisted of the installation of ADA improvements located on several City of San Marcos Facility Locations including City Hall, Library Parking lot, Civic Center Parking Structure, Public Works, and Woodland Park Pool. The work/installations take place at One, Four Civic Center Drive, 201 Mata Way and 671 Woodland Parkway San Marcos CA 92069. The work generally consists of the demolition of existing infrastructure not in ADA compliance and placing the infrastructure back to current ADA standards. The work consists but is not entirely limited to the installation of new Pedestrian Ramps, PCC Pavement and Walkway, Asphalt Concrete, Signs and Striping, Railing, Walls, and Pool Modifications. The work shall be in accordance with the plans and specs. Work shall take place during normal business hours of operation unless otherwise specified by the Director of Real Property Services. During construction pedestrian and vehicle pathways shall be left in an operating condition or approved detours in place. Contractor shall be responsible for all repair work to the building, surrounding landscape, surrounding PCC/AC, and all other damages associated with the installations, work shall be completed to the satisfaction of the City of San Marcos Real Property Services Director or her designee.

### B. Construction Details

- 1. Changes from the Plans and Specifications: The Project was constructed in general accordance with the Contract Documents with the following exceptions: An Additional ADA compliant Pedestrian Ramp and the installation of City provided ADA chair lifts for the two City Pools.
- 2. Working Days: The contract provided 45 working days. The project was suspended and started several times to avoid disruption to pool schedules.
