

RESOLUTION NO. 2021-XXXX

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS, CALIFORNIA, CONFIRMING THE DIAGRAM AND ASSESSMENT AND PROVIDING FOR THE LEVY OF THE ANNUAL ASSESSMENT IN A SPECIAL MAINTENANCE DISTRICT

WHEREAS, the CITY COUNCIL of the CITY OF SAN MARCOS, CALIFORNIA, has initiated proceedings for the levy of the annual assessment for a street lighting district pursuant to the terms and provisions of the "Landscaping and Lighting Act of 1972", (herein the "Act"), being Part 2 of Division 15 of the Streets and Highways Code of the State of California, in a district known and designated as: LANDSCAPING AND STREET LIGHTING DISTRICT NO. 1 (hereinafter referred to as the "District"); and

WHEREAS, the City Council has ordered the preparation of a "Report" as required by the Act, and the City Engineer has prepared and filed this "Report" with the City Council for its consideration, and subsequent thereto this City Council did adopt its Resolution of Intention to levy and collect assessments for the fiscal year commencing July 1, 2021, and ending June 30, 2022, relating to the District, and this City Council did further proceed to give notice of the time and place for a public hearing on all matters relating to the levy of the proposed annual assessment; and

WHEREAS, the City Council has considered all oral statements and all written protests made or filed by all interested persons; and

WHEREAS, the City Council is now desirous of proceeding with the levy of the annual assessment.

NOW, THEREFORE, IT IS HEREBY RESOLVED AS FOLLOWS:

1. That the above recitals are all true and correct.
2. That this City Council hereby approves and confirms the diagram and assessment as modified in the Engineer's "Report".
3. That the adoption of this Resolution constitutes the levy of the assessment for the fiscal year commencing July 1, 2021, and ending June 30, 2022, for the District.
4. That the City Clerk is hereby ordered and directed to file a certified copy of

the diagram and assessment with the County Auditor. Said filing must be completed no later than August 28, 2021.

5. That after the filing of the diagram and assessment, the County Auditor shall enter on the County assessment roll opposite each lot or parcel of land the amount assessed thereupon, as shown in the assessment. The assessment shall be collected at the same time and in the same manner as County taxes are collected, and after collection by the County, the net amount of the assessment, after deduction for any compensation due to the County for collection, shall be paid to the Treasurer of the City.

6. That the diagram and assessment shall be filed in the Office of the City Clerk, with a certified copy to be filed in the Office of the City Engineer. Said diagram and assessment, and the certified copy thereof, shall be open for public inspection.
