SECTION 2. The map in Exhibit 'A' showing the Territory proposed to be annexed to the District and to be subject to the levy of a special tax is hereby approved and adopted.

SECTION 3. The map in Exhibit 'A' is hereby designated as COMMUNITY FACILITIES DISTRICT NO. 98-02 for LIGHTING, LANDSCAPING, OPEN SPACE AND PRESERVE MAINTENANCE (CFD 98-02), ANNEXATION 136, IMPROVEMENT AREA F-57 (IA F-57).
