MICHAEL HUNSAKER, President, Twin Oaks Valley Property Owners Association, spoke in opposition of the sale of real property to the San Marcos Unified School District.

COUNCILMEMBER DISCUSSION INCLUDED: requested further explanation of the sale of real property on 567 Deer Springs Road to the San Marcos Unified School District (SMUSD).

CITY MANAGER GRIFFIN explained that the real property located at 567 Deer Springs Road is owned by the former San Marcos Redevelopment Agency, and is required by the Department of Finance (DOF) to dispose of the property. Meetings with the City, SMUSD staff, and the San Marcos Unified School District Joint Working Group indicated that SMUSD was interested in purchasing the property. The property was appraised at market value and the sale will be contingent upon the approval of the Board of Directors of the School District.

 - 1) Resolution 2018-8515 approved the Operation & Maintenance Budget for FY 2018-19 and Capital Improvement Projects Budget for FY 2018-19 through FY 2022-23 and authorized the appropriation of the funds from the City Treasury. Additionally, this resolution approves the FY 2018-19 classification and compensation schedule.
 - 2) Resolution 2018-8516 approved the appropriation and transfer of funds for the establishment of an appropriated reserve fund for future expenditures and/or contingencies for FY 2018-19.
 - 3) Resolution 2018-8517 approved setting the tax rate for FY 2018-19.

BUDGET REVIEW COMMITTEE CHAIR CHARLES ZAHL presented a review of the City's balance budget.

FINANCE AND IT DIRECTOR LAURA ROCHA presented the Operation & Maintenance budget.

PUBLIC WORKS MANAGER LISA FOWLER presented the Capital Improvement Project Budget.

COUNCILMEMBER DISCUSSION INCLUDED: property and sales tax increases; Ad Volarem & Real Property Transfer Tax Funds (RPTTF); Proposition 13 tax implications; re-assessment of property values; vehicle fleet replacement; new full-time positions (Leasing Analyst and Fire Mechanic); facilities replacement/rehabilitation fund; future budget concerns; future economic downturns; timeline on the East Mission Fiber Optic Project; San Marcos Sheriff's contract; general fund utility savings; road maintenance and accountability fund; homelessness problem; additional Resource Service Officer (RSO); Historical Pink House preservation; and Senate Bill 1 (SB1) repeal implications.

CITY STAFF RESPONDED: Property tax increases are a combination of growth in the city and redevelopment dissolution pass-thru dollars added to the general fund; sales tax increases are a result of the building industry and construction; the increases to the Ad Volarem tax is 2-4% every year based on the assessed valuation; Proposition 13 property tax rate is 8 cents on the dollar; and the Fire Mechanic position in Public Works will specifically service fire vehicles to enable a faster repair time.

CITY MANAGER GRIFFIN responded that Proposition 13 allowed cities to choose their property tax rate; the SMUSD requested a need for an additional Resource Service Officer (RSO) to be placed at a school site; San Marcos Unified School District Superintendant, Melisa Hunt, agreed to split the cost of the RSO position 50/50, and will increase their percentage every year until SMUSD fully funds the position; and Senate Bill 1 (SB1), if repealed, will initiate budget funding changes for City Council approval.

CITY ATTORNEY PEAK stated that a change to property taxes, at the very least, would require a vote of the people.

DEPUTY CITY MANAGER MATT LITTLE stated that the city is working on a plan to update, paint and preserve the Historical Pink House by December 2018; and the fiber optic project to connect the signals to the fiber optic lines is 75% completed.

CAPTAIN DAVE BROWN, San Marcos Sheriff Department, explained that the Sheriff's Department did a security assessment of every school in the San Marcos Unified School District, and agreed that having an additional third Resource Service Officer on site at one of the schools would be beneficial to the safety of students and the community.

MOVED BY COUNCILMEMBER ORLANDO, SECOND BY COUNCILMEMBER JARARA TO ADD A THIRD SCHOOL RESOURCE SERVICE OFFICER TO THE CONTRACT WITH THE SAN DIEGO COUNTY SHERIFF'S DEPARTMENT IN THE LAW ENFORCEMENT BUDGET AT A COST OF \$102,000.

MOVED BY MAYOR DESMOND, SECONDED BY VICE MAYOR JONES AND CARRIED UNANAIMOUSLY TO INCREASE HOUSING SUPPORT FROM THE CITY'S AFFORDABLE HOUSING FUND FROM \$67,700 TO \$125,000 FOR THE ALLIANCE FOR REGIONAL SOLUTIONS.
