

RESOLUTION NO. 2014-XXXX

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS,
CALIFORNIA, SUPPORTING THE RE-DESIGNATION OF NORTH SAN
DIEGO COUNTY AS A RECYCLING MARKET DEVELOPMENT ZONE DUE
TO AN INCREASE IN BOUNDARIES AND ADOPTION OF NEGATIVE
DECLARATION ADDENDUM

WHEREAS, California law provides for the establishment of the Recycling Market Development Zone (RMDZ) program to provide incentives to stimulate development of post consumer and secondary materials markets throughout the state; and

WHEREAS, the City of San Marcos has participated since 1994 in the North San Diego County RMDZ, which includes the cities of Carlsbad, Del Mar, Escondido, Oceanside, Poway, San Diego, San Marcos, Solana Beach, Vista, and the County of San Diego; and

WHEREAS, the City of San Marcos renewed its participation in the North San Diego County RMDZ in 2004 for another 10 years; and

WHEREAS, the North San Diego County RMDZ will expire on November 16, 2014 unless re-designated by the California Department of Resources Recycling and Recovery (CalRecycle); and

WHEREAS, the City of San Marcos must meet a 50% landfill waste disposal reduction as mandated by the California Integrated Waste Management Act; and

WHEREAS, the renewal of the North San Diego County RMDZ would assist the City of San Marcos in meeting the mandated reductions in landfill waste while also helping local business development and enhancing environmental quality for its residents; and

WHEREAS, the renewal of the North San Diego County RMDZ is still necessary to retain the eligibility of businesses for technical and financial incentives associated with the RMDZ program and to attract private sector recycling business investments to the region; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of San Marcos as follows:

1. The City of San Marcos hereby adopts the Negative Declaration Addendum prepared by the County of San Diego dated January 31, 2014.
2. The City of San Marcos approves the renewal of North San Diego County as a RMDZ and directs the County of San Diego to submit an application to CalRecycle requesting re-designation of North San Diego County as a RMDZ to include the cities of Carlsbad, Del Mar, Encinitas, Escondido, Oceanside, Poway, San Diego, San Marcos, Santee, Solana Beach, Vista, and the County of San Diego.
3. The City Council authorizes the City Manager to sign all appropriate documents required for the RMDZ application and renewal.
