RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS APPROVING CONSTRUCTION DOCUMENTS FOR THE 2026 PAVEMENT OVERLAY PROJECT (CIP #ST022), AUTHORIZING THE CITY ENGINEER TO FINALIZE THE SAME, AUTHORIZING ADVERTISEMENT FOR BID, AND DELEGATING TO AND AUTHORIZING THE CITY MANAGER TO AWARD, NEGOTIATE, FINALIZE, AND EXECUTE THE CONSTRUCTION CONTRACT DOCUMENTS, AND APPROPRIATING ADDITIONAL FUNDS FOR SAID PROJECT

WHEREAS, construction documents for the 2026 Pavement Overlay Project (CIP #ST022, "Project") have been substantially completed; and

WHEREAS, the Project improvements will include pavement rehabilitation, construction of intersection signal improvements, new buffered bike lane striping, and ADA improvements on Barham Drive, Woodland Parkway, Rancheros Drive, Nordahl Road, Center Drive, and Avenida Ricardo; and

WHEREAS, the City of San Marcos desires to complete the construction of the Project in an expeditious manner; and

WHEREAS, delegating to and authorizing the City Manager to award the contract for the Project and to negotiate, finalize, and execute the applicable contract documents will facilitate the expeditious and orderly construction of the Project; and

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of San Marcos hereby:

1. Approves the construction documents for the 2026 Pavement Overlay Project (CIP #ST022) and authorizes the City Engineer to finalize the same; and
2. Authorizes the advertisement for bid for the 2026 Pavement Overlay Project (CIP #ST022); and
3. Delegates to and authorizes the City Manager to award a contract and to negotiate, finalize, and execute the construction contract documents with the lowest responsive and responsible bidder for the 2026 Pavement Overlay Project (CIP #ST022); and
4. Amends the FY 2025-26 Capital Improvement Program Budget to appropriate \$110,000 from the Center Drive Maintenance District Fund (Fund 211) balance to CIP #STO22.
