

RESOLUTION NO. 2019-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS AWARDING A PURCHASE CONTRACT WITH PIERCE MANUFACTURING, INC. AND A LEASE AGREEMENT WITH PNC EQUIPMENT FINANCE, LLC FOR TWO (2) TYPE I FIRE ENGINES AND PURCHASE OF ASSOCIATED SUPPORT EQUIPMENT

WHEREAS, the City Council approved the Fiscal Year 2019-2020 adopted budget, which includes funding for the leasing of two (2) Type I Fire Engines and associated support equipment, as part of the Vehicle & Equipment Replacement Fund schedule; and

WHEREAS, the San Marcos Fire Department has prepared specifications for two (2) Type I Fire Engines; and

WHEREAS, the acquisition of two (2) Type I Fire Engines will help to maintain a standardized fleet of modern up-to-date apparatus and extend vehicle years of service; and

WHEREAS, the cooperative leasing program, H-GACBuy, has engaged in a competitive bidding process for two (2) Type I Fire Engines, and has selected Pierce Manufacturing, Inc. as a vendor for such equipment through such public bidding process; and

WHEREAS, Fire Department staff has evaluated comparable costs and has determined that the H-GACBuy cooperative purchasing program price for such equipment is below the cost of comparable vehicles; and

WHEREAS, Pierce Manufacturing, Inc. is also the original manufacturer of all front line engines and truck in the Fire Department's fleet, which, in addition to the leasing options and price, is one of the Department's determining factors in selecting Pierce Manufacturing, Inc., for the purchase of two (2) Type I Fire Engines; and

WHEREAS, the Type I Fire Engines will be purchased from Pierce Manufacturing, Inc. leased from Pierce Manufacturing, Inc., based on San Marcos Fire Department specifications, pursuant to the provisions of San Marcos Municipal Code section 2.30.110.

WHEREAS, the City is authorized to enter into a one or more Master Lease-Purchase Agreements ("Lease/s") with PNC Equipment Finance, LLC ("Lessor") for purposes of financing the Type I Fire Engines

NOW, THEREFORE, BE IT RESOLVED that:

1. The foregoing recitals are true and correct.
2. The City Manager or his designee is hereby authorized and directed to negotiate, engage in, enter into, and execute the purchase contract per the above described program for two (2) 2019 Type I Fire Engines as specified by the San Marcos Fire Department.

3. The City Manager or his designee is hereby authorized and directed to negotiate, engage in, enter into, execute and deliver the Lease/s as per the above described program for the lease of two (2) 2019 Type I Fire Engines as specified by the San Marcos Fire Department.

4. The City Manager is hereby authorized to expend the sum of:
