PRELIMINARY REPORT PURSUANT TO
"LANDSCAPING AND LIGHTING ACT OF 1972"

Pursuant to direction from the City Council, submitted herewith is the Report, consisting of the following parts, pursuant to the provisions of Division 15, Part 2 of the Streets and Highways Code of the STATE OF CALIFORNIA, being the "Landscaping and Lighting Act of 1972," commencing with Section 22500. This Report is applicable for the ensuing 12-month period, being the fiscal year commencing July 1, 2019 to June 30, 2020.

- Part 1. **PLANS AND SPECIFICATIONS** of the improvements to be maintained and/or improved for the fiscal year. The plans and specifications show and describe the existing improvements, and are sufficient in showing and describing the general nature, location and extent of the improvements.
- Part 2. **AN ESTIMATE OF THE COSTS** of the improvements to be maintained and/or improved for the mentioned fiscal year.
- Part 3. **AN ASSESSMENT ROLL** showing the proportionate amount of the assessment to be charged in proportion to the benefits to be received by each lot or parcel within the exterior boundaries as shown on the below-referenced Diagram.
- Part 4. **A DIAGRAM** of the Landscaping and Lighting District No. 1 (the "District"). Said Diagram shall show the exterior boundaries of the District and the boundaries of any zones within the District. Reference is made to the County Assessor's Maps for a detailed description of the lines and dimensions of any lots or parcel. The lines and dimensions of each lot shall conform to those shown on the County Assessor's Maps for the fiscal year to which the Report applies. (DIAGRAM ON FILE WITH THE CITY ENGINEER).

All lots and parcels of land known as public property, as defined under Section 22663 of said "Landscaping and Lighting Act of 1972," have been omitted and are exempt from any assessment under these proceedings.

A full-size Diagram showing the boundaries of the District and benefit zones established within the District are the same which existed at the time of the adoption of the Resolution of Intention, and the initiation of these proceedings is on file in the Office of the City Engineer of the City of San Marcos.

A copy of the Assessment Roll and Final Engineer's Report were filed in the Office of the City Clerk on the 30th day of July, 2019.



Final approval, confirmation and levy of the annual assessment and all matters in the Report were made on the 9th day of July, 2019, by adoption of Resolution No. 2019-_____ by the City Council.

PLANS AND SPECIFICATIONS

CITY OF SAN MARCOS

PUBLIC LIGHTING FACILITIES

All public lighting facilities within the District are:

- Located within the City of San Marcos as shown on the Diagram included herein as Part IV.
- Owned and maintained by the City of San Marcos.
 - Identified further by wattage and number of months maintained on the Cost Estimate included herein as Part II.

Reference is made to the Plans and Specifications for the lighting improvements which are on file in the City of San Marcos Engineering Department.

The work to be done consists of the furnishing of all electric current and necessary labor, materials and equipment for the maintenance of all the existing public lighting facilities. The San Diego Gas and Electric Company furnishes electric current to all lighting facilities and provides switching service for lighting said lamps from fifteen (15) minutes after sunset to thirty (30) minutes before sunrise each and every day of the year. The electric current supplied shall not vary more than five percent (5%) plus or minus from that for which the system was designed.

The lighting shown on the Diagram included herein as Part IV has been identified in zones as follows:

1. **Zone "A" - Residential Lighting**

This area contains primarily developed residential lots serviced by underground power. The intensity ranges from 7,000 lumens to 30,000 lumens. The lights are at intersections and cul-de-sacs, and curves on the public streets.

2. **Zone "B" - Commercial, Industrial or Residential High Intensity Lighting**

This area, contains primarily commercial, industrial, or highly developed multiple residential property. The light intensity ranges from 7,000 to 50,000 lumens. The lights are at intersections, cul-de-sacs and curves on collector or higher use streets.

LANDSCAPE IMPROVEMENTS

All landscaping improvements have or are under the process of being accepted by the City of San Marcos for maintenance.



The work to be done consists of the maintenance of all landscaping and appurtenant facilities in medians and parkways. Maintenance shall include the furnishing of services and materials for the ordinary and usual maintenance, operation and servicing of all landscaping and appurtenant facilities, including providing for the life, growth, health and beauty of landscaping by replacement, cultivation, irrigation, trimming, spraying, fertilizing, treating for disease or injury and the removal of trimmings, rubbish, debris and other solid waste.

The medians and parkways being maintained are listed on the Cost Estimate included herein as Part II and are shown on the Diagram included herein as Part IV. Reference is made to the Plans and Specifications for the landscape and irrigation improvements which are on file in the City of San Marcos Engineering Department.

Landscaped areas are designated as Zone "C" on the Diagram included herein as Part IV.

All work to be done and the services to be rendered, herein provided for, shall be done under the general supervision of the Director of Public Works of the City of San Marcos.

ASSESSMENT ROLL

I do hereby assess and apportion the total amount of the costs and expenses upon the several parcels of land within said District liable thereof and benefited thereby, in proportion to the estimated benefits that each parcel receives, respectively, from said maintained works of improvement and appurtenances as established in the formation of said District.

All of the parcels within the District are located within the City of San Marcos and have approved developments or are in the final stages of obtaining approval for a proposed development. As a condition of approval, the developer is required by the City to provide:

1. Certain standard street lighting for the entire area within the development; and the energy costs for the initial 18-month period; and/or
2. Certain median and/or parkway landscaping improvements; and the maintenance and utility costs for the initial 18-month period.

No area or portion thereof is assessed prior to the completion of the initial 18-month period for the respective development.

The District provides funding for the:

- Furnishing of services and materials for the ordinary and usual maintenance, operation and servicing of the installed street lights, including the furnishing of electric current;
- Lighting systems management including street light master planning and location requirements, processing of San Diego Gas and Electric contracts and payments, and maintenance of plans and specifications;
- Furnishing of services and materials for the ordinary and usual maintenance of the landscaping and irrigation improvements, including the furnishing of water and electric current;
- Landscaping systems management, including the determination of area requirements and inspections, the processing of contracts and payments, and the maintenance of plans and specifications;
- Incidental costs, including engineering and legal expenses.



Assessment Criteria: The improvements and annexation into Landscaping and Lighting District No. 1 are conditions of approval for various developments and by nature of the improvements benefit the respective development. Thus, the parcels receive a special and direct benefit distinguished from that of the general public. The method of assessment, by improvement is as follows:

Public Lighting Facilities

The method of assessment is based on units, with a single-family dwelling equal to one benefit unit. The relationship between single-family lots and apartments, mobile-home parks and commercial/manufacturing has been established at 2.65 single-family lots (EDU) to one acre. This relationship is based on the average density of single-family developments in the City of San Marcos.

There are single-family, condominium and mobile-home lots within the City that are individually owned and located on private streets. The assessment units assigned to each lot or unit in these areas were determined by multiplying the total area of the respective development by the 2.65 equivalency factor and dividing the product by the number of lots or units within the development.

For example, the EDU per dwelling unit for 80 dwelling units located on 25 acres is calculated as follows:

$$25 \text{ acres} \times \frac{2.65 \text{ EDU}}{\text{Acre}} \times \frac{1}{80 \text{ Dwelling Units}} = \frac{0.83 \text{ EDU}}{\text{Dwelling Unit}}$$

Parcels were assessed according to the type of lighting provided. For example, all parcels benefiting from 55 watt, 8,000 lumen, LS2A lights were assessed the costs of this lighting based on the assessment units assigned to those parcels. If a parcel benefits from more than one lighting type, that parcel is assessed its share of the cost of each lighting type.

The dollar per single-family lot or EDU, by lighting type, for Fiscal Year 2017-2019 are as follows:

Landscaping Improvements

In general, the method of assessment is based on frontage. Each median and parkway has been assessed to parcels that front the respective improvements.

However, there are areas where the median and/or parkways benefit the entire development and not just parcels that front the improvement. The parcels in these areas have been assessed according to acreage.

The cost per unit by median and parkway is listed as follows:

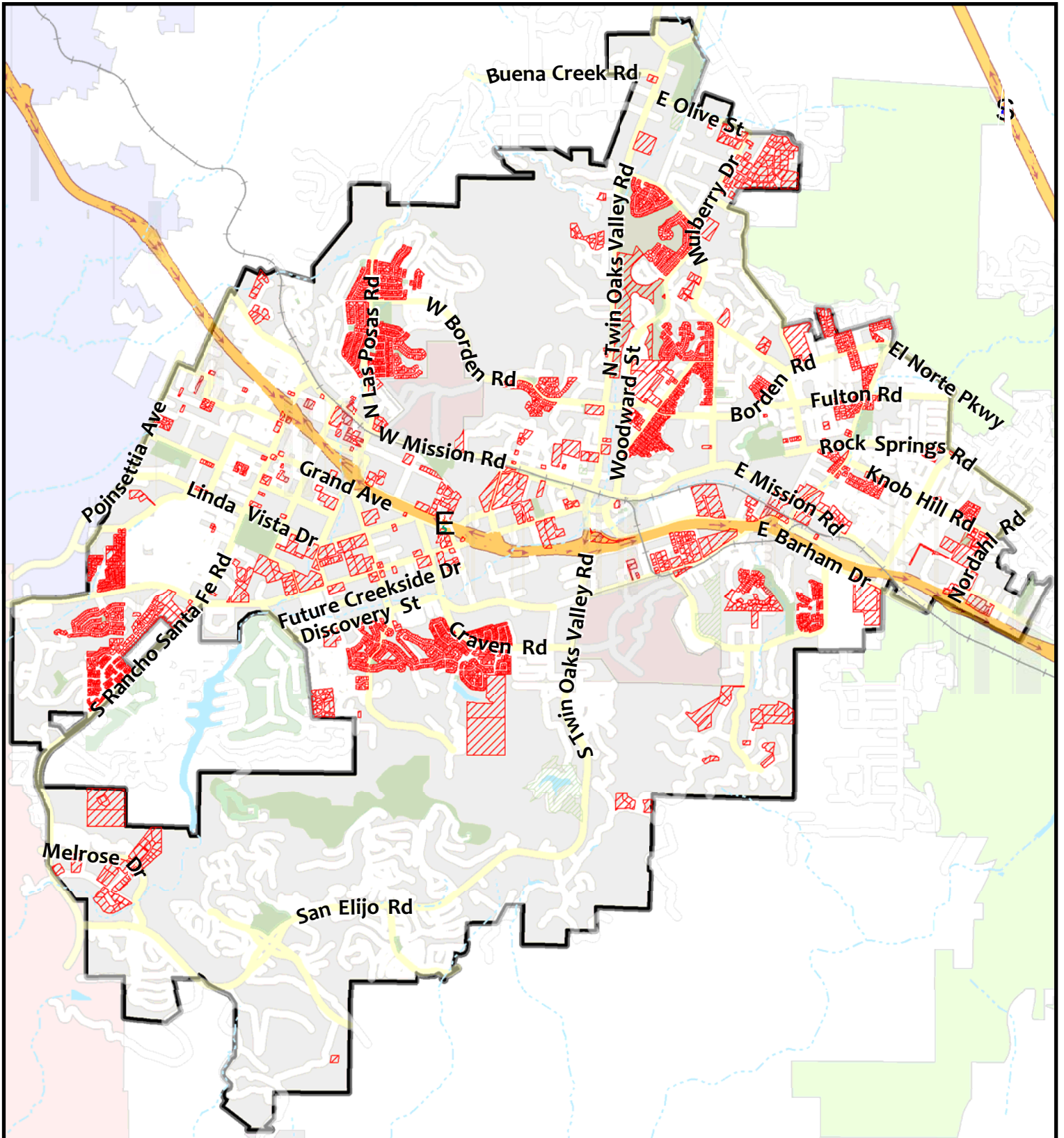
CITY OF SAN MARCOS
