A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS, CALIFORNIA, CONFIRMING THE DIAGRAM AND ASSESSMENT AND PROVIDING FOR THE LEVY OF THE ANNUAL ASSESSMENT IN VALLECITOS TOWN CENTER STREET MAINTENANCE DISTRICT

WHEREAS, the City Council of the City of San Marcos, California, has initiated proceedings for the levy of the annual assessment for a street lighting district pursuant to the terms and provisions of the "Landscaping and Lighting Act of 1972" (hereinafter "the Act"), being Part 2 of Division 15 of the Streets and Highways Code of the State of California, in a district known and designated as: VALLECITOS TOWN CENTER STREET MAINTENANCE DISTRICT (hereinafter the "District); and

WHEREAS, the City Council ordered the preparation of a report as required by the Act (hereinafter "the Report"), the City Engineer prepared and filed the Report with the City Council for its consideration, this City Council did subsequently adopt its Resolution of Intention to levy and collect assessments relating to the District for the fiscal year commencing July 1, 2025, and ending June 30, 2026, and this City Council did further proceed to give notice of the time and place for a public hearing on all matters relating to the levy of the proposed annual assessment; and

WHEREAS, the City Council has considered all oral statements and all written protests made or filed by all interested persons; and

WHEREAS, the City Council now desires to proceed with the levy of the annual assessment.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SAN MARCOS HEREBY RESOLVES AS FOLLOWS:

- 1. That the above recitals are all true and correct.
- 2. That this City Council hereby approves and confirms the maximum authorized assessment for FY 2025-2026, the proposed levy for the same period, as well as the diagram as provided in the Engineer's Report and the spreadsheet attached hereto as

Exhibit A and Exhibit B, respectively.

3. That the adoption of this Resolution constitutes the levy of the assessment

for the fiscal year commencing July 1, 2025, and ending June 30, 2026, for the District.

4. That the City Clerk is hereby ordered and directed to file a certified copy of

the diagram and assessment with the County Auditor. Said filing must be completed no

later than August 29, 2025.

5. That after the filing of the diagram and assessment, the County Auditor shall

enter on the County assessment roll opposite each lot or parcel of land the amount

assessed thereupon, as shown in the assessment. The assessment shall be collected at

the same time and in the same manner as County taxes are collected, and after collection

by the County, the net amount of the assessment, after deduction for any compensation

due to the County for collection, shall be paid to the Treasurer of the City.

6. That the maximum authorized assessment for FY 2025-2026, the proposed

levy for the same period, and the diagram shall be filed in the Office of the City Clerk, with

a certified copy to be filed in the Office of the City Engineer. Said maximum authorized

assessment, assessment, and the certified copy thereof, shall be open for public

inspection.
