- RESOLUTION NO. 2018-8553 AUTHORIZING THE CITY MANAGER TO MAKE CERTAIN REAL PROPERTY HELD TO DATE FOR INVESTMENT PURPOSES AVAILABLE FOR SALE, AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE, FINALIZE AND EXECUTE ALL NECESSARY AGREEMENTS, CONTRACTS, AND DOCUMENTATION TO EFFECTUATE THE SALE OF SUCH PROPERTIES, IDENTIFIED AS Assessor's Parcel Numbers 182-076-01, 182-076-02, 182-076-03, 220-050-09, 221-720-31, 222-042-14, 222-042-17, and 222-042-20. Approved a resolution authorizing the City Manager to make certain real property held by the City to date for investment purposes, identified as set forth above, available for sale, and to authorize the City Manager and City Attorney to negotiate, finalize, and execute all necessary agreements, contracts, and documentation to effectuate the sale of such properties, to maximize to the extent possible the City's return on its investment.

4) RESOLUTION NO. 2018-8550 - ACCEPTANCE AND AUTHORIZE FILING NOTICE OF COMPLETION FOR THE SR-78 EASTBOUND AUXILIARY LANE IMPROVEMENT CAPITAL IMPROVEMENT PROGRAM PROJECT (CIP #88247). Approved a resolution accepting the improvements included in the SR-78 Eastbound Auxiliary Lane Improvement Capital Improvement Program Project (CIP #88247) and authorizing staff to file a Notice of Completion. THIS ITEM WAS REMOVED FROM THE CONSENT CALENDAR.

COUNCILMEMBER DISCUSSIONS INCLUDED: clarification on the change orders and whether 10% is a reasonable number for the project; and responsibility for ongoing landscaping, and maintenance.

CITY MANAGER GRIFFIN explained that the Nordahl Rd. Auxiliary Lane Improvement Project was completed July, 2013 with a 5 year landscape maintenance period, completed August, 2018; there were twenty-six change orders, including large cost items such as rock distribution, retaining walls, and significant changes to the traffic management program; a 10% increase in change orders was reasonable for this type of complicated project and the City and CALTRANS will be responsible for ongoing landscape and maintenance of the interchange.

9) ORDINANCE NO. 2018-1467 - AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS, CALIFORNIA, AMENDING SAN MARCOS MUNICIPAL CODE CHAPTERS 6.04, 6.08, 6.12, 6.16, 6.20, 6.28 AND 6.32 AND REPEALING AND REPLACING CHAPTER 6.24 RELATING TO ANIMAL CONTROL. Approved first reading of an ordinance to amend the San Marcos Municipal Code Chapters 6.04, 6.08, 6.12, 6.16, 6.20, 6.28 and 6.32, and repeal and replace Chapter 6.24 relating to animal control.

DEPUTY CITY ATTORNEY HOUSE presented the staff report.

COUNCIL DISCUSSIONS INCLUDED: clarification on physicians reporting animal bites; kennel compliance; and process for animal complaints and hearings.

CHIEF MCKINNON, Humane Society Law Enforcement, responded that his office will be in control of the administrative hearings for violations, and the modifications to the animal control ordinance enables the City of San Marcos and San Diego Humane Society enforcement officers to continue to enforce and protect the residents and animals in the city.

CITY MANAGER GRIFFIN responded that animal complaints can be reported using the City's website, or contact the San Diego Humane Society.

CITY ATTORNEY PEAK responded that all parties associated with animal bites (physicians, owners and victims) are required to report the incidents to the San Diego Humane Society or the County Health Officer as soon as possible, and failure to report is a violation of the city code; and that the concerns emailed by a resident, were identified and handled as much as legally possible within the amended ordinance.
