This irrevocable offer to dedicate is made on behalf of and shall bind me/us and my/our heirs, successors, and assigns. This instrument shall be and constitute an irrevocable offer to dedicate the above described real property for public street purposes, and said offer may not be revoked by the undersigned, their heirs, successor of assigns of the undersigned. The undersigned hereby reserves the right to use the property for any and all uses of said land except the erection or construction of a building thereon until such time as the legislative body of the City of San Marcos shall, without further action on its part, or the part of its heirs, successors, and assigns, accepts this irrevocable offer and records a certificate of acceptance.
