



I also hope to see continued investment in programs that strengthen families, support seniors, and promote overall health and well-being in our community, so that everyone in San Marcos has the opportunity to thrive.

The most interesting aspect of this commission to me is the opportunity to have a direct impact on programs and initiatives that improve the quality of life for residents of San Marcos. 

As Parks & Rec Commissioner, I have experience across parks and recreation operations, including supporting youth and adult recreational sports programs, participating in Senior Activity Center programs, and asking Parks & Rec staff critical questions about the planning and delivery of seasonal classes, camps, and facility-based programs. I'm involved in the Trails Advisory Committee and Youth Sports Commission demonstrates a strong understanding of community partnerships and youth engagement. When the shift in aquatics programming delivery was in the development phase, I participated in months-long conversations to ensure that the costs/benefits for the San Marcos City and community were central to those conversations and played an active role in developing an e-bike policy in advance of neighboring cities, highlighting proactive planning and policy awareness. On a regular basis, my participation in monthly community hikes reflects my commitment to fostering outdoor recreation and community wellness initiatives.

Over the years, the Trails Advisory Committee has amplified concerns and provided research for improved trail signage that is consistent for all 72 miles of trails. This project would expand trail safety. This will be no surprise to you but expanded after-school and teen engagement programs would benefit our youth. While there is a Youth Commission, there may be opportunities to directly engage with the San Marcos School District to collaborate and expand programs and projects that have seen teen engagement numbers (increase or maintain) consistently.



I have served on the CAP Working Group since the summer of 2022, when I was completing my master's degree with a focus on local community resilience and sustainability planning. During the most recent session, I was selected to serve as chair of the group. As my career has focused on international development, I have enjoyed engaging with local issues and serving as a community representative.

In regard to other relevant experience, this year I participated in several community events. This included learning opportunities during the inaugural San Diego Climate Week. I also attended the San Diego County Water Authority's Citizens Water Academy, as well as the San Diego Food System Alliance's Annual Gathering. Additionally, my volunteer work with the Agrarian Institute at the Bonsall Berry Farm has highlighted the importance of localizing our food system while advancing climate-smart agricultural practices.

WHAT CITY PROGRAMS/PROJECTS WOULD YOU LIKE TO SEE IMPROVED OR IMPLEMENTED?

With the City acquiring funds to revise the current Climate Action Plan early, the topic of community engagement and education has consistently come up in our meetings. The committee believes this should be a next step for the CAP. If we are to make meaningful progress on the climate crisis, it will require action from all of us. The City should be proud of the work done so far while continuing to reduce greenhouse gas emissions and mitigate their impacts through carbon sequestration efforts such as tree planting. Further utilizing the CAP Working Group to engage the community is one recommended area for improvement.

MOST INTERESTING ASPECT OF THIS COMMISSION TO YOU?

I am grateful to live in California, where efforts to combat the climate crisis are directed from Sacramento and implemented at the local level. Learning about how the City of San Marcos is reworking building codes, sourcing renewable energy through CEA, reducing vehicle miles traveled, engaging in active transportation planning, diverting green waste from landfills, and revisiting landscaping decisions are among the topics that have piqued my interest over the years. It has been an honor to be a voice for the community, and I look forward to continuing to serve the City of San Marcos and my neighbors in this way.
