related to the collection and expenditures of public facilities fees as required by the applicable Government Code section.

FINANCE DIRECTOR ROCHA explained the negative interest was a result of the parks category of the Public Facilities Fees (PFF) fund being used for other large City Council approved expenditures. The appropriated funds were then not available for interest earnings. The negative interest illustrates the potential earnings had the funds remained intact and for future repayment of the borrowed funds.

Clarified that NPDES stands for National Pollution Discharge Elimination System which is a storm water quality related issue dealing with the treatment and removal of pollutants from storm water runoff.

BRAD WELEBIR, Audit Manager for field work and reporting, provided information regarding the summary of audit results letter provided to the City Council.

Discussion included clarification of Government Accounting Standards Bill (GASB) 65 and GASB 68, the City's net worth, the increase in assessed value and property taxes decreasing as it relates to the ROPS cycles, and the amount of funds due to other governmental entities.
