

ORDINANCE NO. 2020-1488

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS, CALIFORNIA, AUTHORIZING AN AMENDMENT TO THE CONTRACT BETWEEN THE CITY OF SAN MARCOS AND THE BOARD OF ADMINISTRATION OF THE CALIFORNIA PUBLIC EMPLOYEES' RETIREMENT SYSTEM (CalPERS)

WHEREAS, the City of San Marcos (City) and the California Public Employees' Retirement System (CalPERS) entered into a contract effective November 15, 1972, which has subsequently been amended in 1983, 1990, 1999, 2001, 2005, 2012, 2015 and 2019 (Contract); and

WHEREAS, the Contract provides list of optional contract provisions available to contracting agencies through various sections of the Public Employees' Retirement Law; and

WHEREAS, the City has elected to add Section 20516 optional contract provision (Employees Sharing Additional Cost) for classic and new members of Fire Safety, Fire Management, Classified Miscellaneous, Supervisory and Unrepresented positions;

WHEREAS, CalPERS has requested contract amendment to add Section 20516 optional contract provision (Employees Sharing Additional Cost) to the Contract.

NOW THEREFORE, the City Council of the City of San Marcos, in accordance with the freedom accorded to charter cities generally, and by the Charter of the City of San Marcos, does ordain as follows:

Section 1. That an amendment to the contract between the City Council of the City of San Marcos and the Board of Administration, California Public Employees' Retirement System is hereby authorized, a copy of said amendment being attached hereto, marked Exhibit, and by such reference made a part hereof as though herein set out in full.

Section 2. The City Manager of the City of San Marcos is hereby authorized, empowered, and directed to execute said amendment for and on behalf of said Agency.

Section 3. This Ordinance shall take effect thirty (30) days after the date of its adoption. Within fifteen (15) days following its adoption, the City Clerk shall publish this Ordinance of the title thereof, as a summary as requested by state law.

Section 4. The City Clerk shall certify to the passage of this Ordinance and cause the same to be published in accordance with the provisions of State Law in a newspaper of general circulation designated for legal notices publication in the City of San Marcos.
