NEW BUSINESS

 ORDINANCE NO. 2020-1492 - AN URGENCY ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS, CALIFORNIA, ENACTING A TEMPORARY MORATORIUM ON EVICTIONS DUE TO NONPAYMENT OF RENT FOR RESIDENTIAL TENANTS IMPACTED BY THE NOVEL CORONAVIRUS (COVID-19) Adopted an urgency ordinance enacting a temporary moratorium on evictions due to nonpayment of rent for residential tenants impacted by the novel coronavirus (COVID-19).

CITY ATTORNEY PEAK provided the staff report.

COUNCILMEMBER DISCUSSION INCLUDED: number of inquiries; retroactive enforcement of ordinance; timeframe for the ordinance moratorium and repayment; authority of local jurisdictions to enforce evictions and relationship to State legislation; required notification of evictions; and small claims court dollar limits for evictions.
