A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SAN MARCOS AWARDING A PURCHASE CONTRACT TO
SOUTH COAST FIRE EQUIPMENT, INC./PIERCE
MANUFACTURING AND A LEASE AGREEMENT WITH PNC
EQUIPMENT FINANCE, LLC FOR ONE (1) TYPE III FIRE
ENGINE AND PURCHASE OF ASSOCIATED SUPPORT
EQUIPMENT

WHEREAS, the City Council approved the Fiscal Year 2020-2021 adopted budget, which includes funding for the lease of one (1) Type III Fire Engine and associated support equipment, as part of the Vehicle & Equipment Replacement Fund (602); and

WHEREAS, the San Marcos Fire Department has prepared specifications for one (1) Type III Fire Engine; and

WHEREAS, the acquisition of one (1) Type III Fire Engine will help maintain a standardized fleet of modern apparatus and extend vehicle years of service; and

WHEREAS, the cooperative leasing program, H-GACBuy, has engaged in a competitive bidding process for one (1) Type III Fire Engine, and has selected South Coast Fire Equipment, Inc./Pierce Manufacturing as a vendor for such equipment through such public bidding process; and

WHEREAS, Fire Department staff has evaluated comparable costs and has determined that the H-GAC Buy cooperative purchasing program price for such equipment is below the cost of comparable vehicles; and

WHEREAS, Pierce Manufacturing is also the original manufacturer of all front line engines and trucks in the Fire Department's fleet, which in addition to leasing options and price, is one of the Department's determining factors in selecting South Coast Fire Equipment, Inc./Pierce Manufacturing for this Type III Fire Engine purchase; and

WHEREAS, the Type III Fire Engine will be purchased from South Coast Fire Equipment, Inc./Pierce Manufacturing, leased through PNC Equipment Finance, LLC and designed based on San Marcos Fire Department specifications, pursuant to the provisions of San Marcos Municipal Code section 2.30.110.

WHEREAS, the City is authorized to enter into a one Master Lease-Purchase Agreement ("Lease") with PNC Equipment Finance, LLC ("Lessor") for purposes of financing the Type III Fire Engine.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The foregoing recitals are true and correct.

2. The City Manager or his designee is hereby authorized and directed to negotiate, engage in, enter into, and execute the purchase contract per the above described program for one (1) Type III Fire Engine as specified by the San Marcos Fire Department.
3. The City Manager or his designee is hereby authorized and directed to negotiate, engage in, enter into, execute and deliver the Lease as per the above described program for the lease of one (1) Type III Fire Engine as specified by the San Marcos Fire Department.
4. The City Manager is hereby authorized to expend the sum of \$612,000 which includes, but is not limited to, principal, interest and equipment
